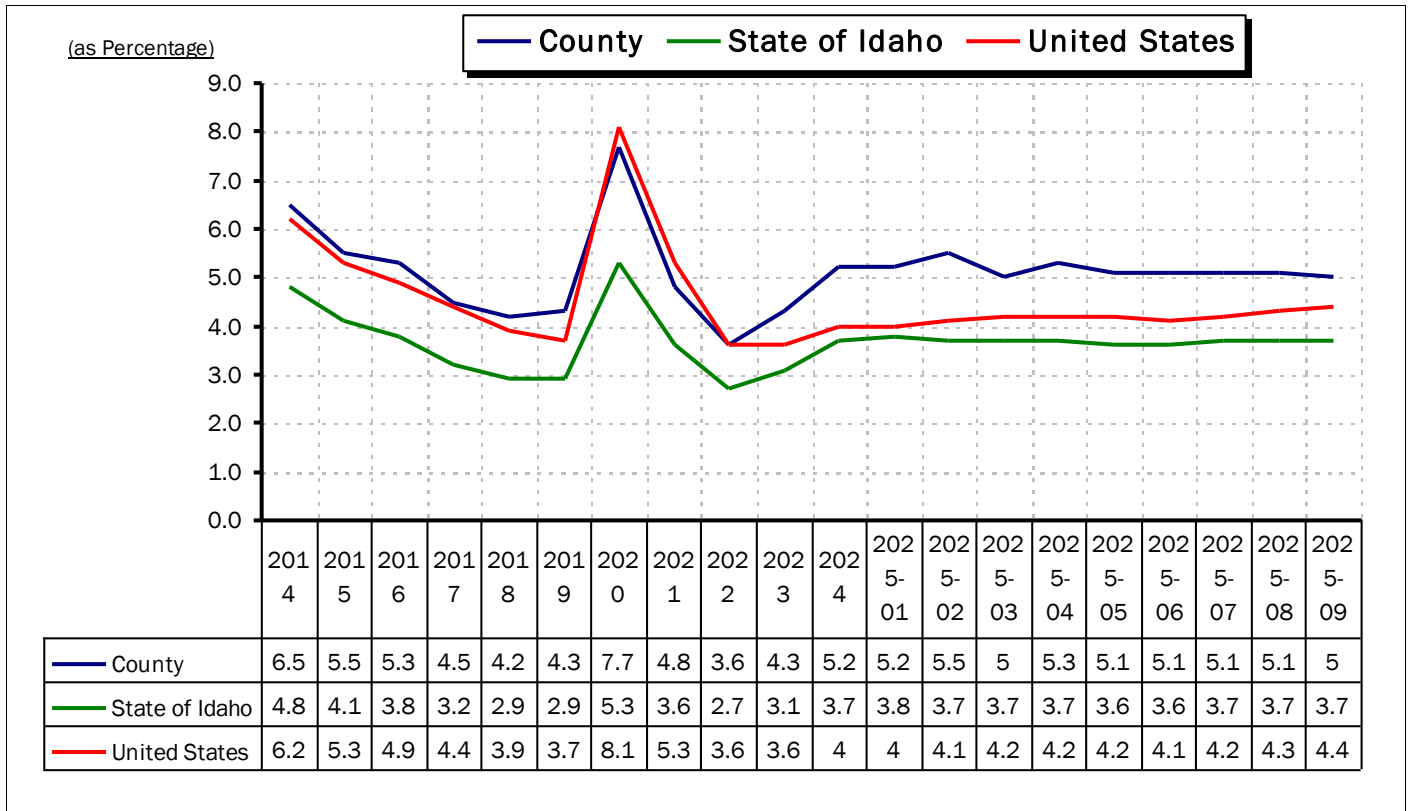

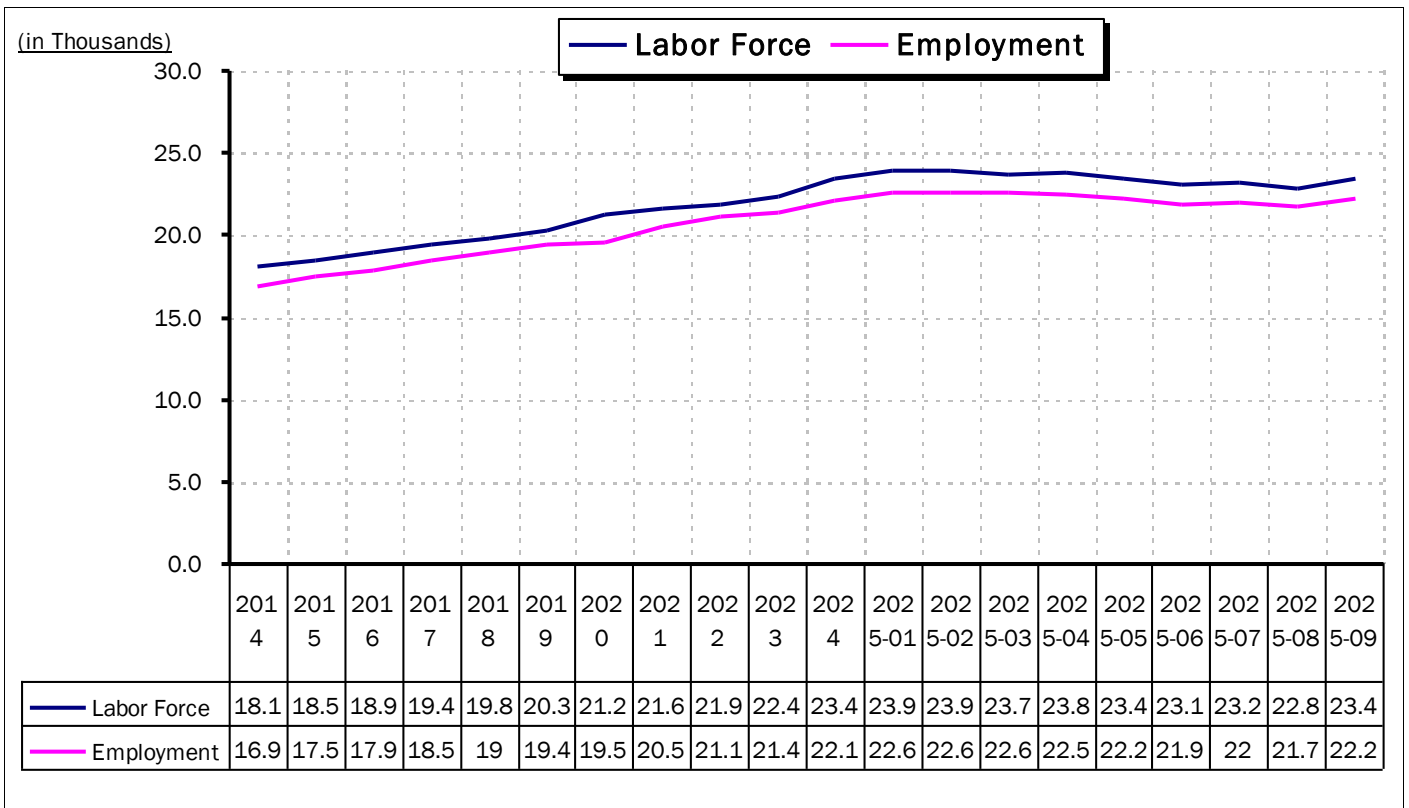

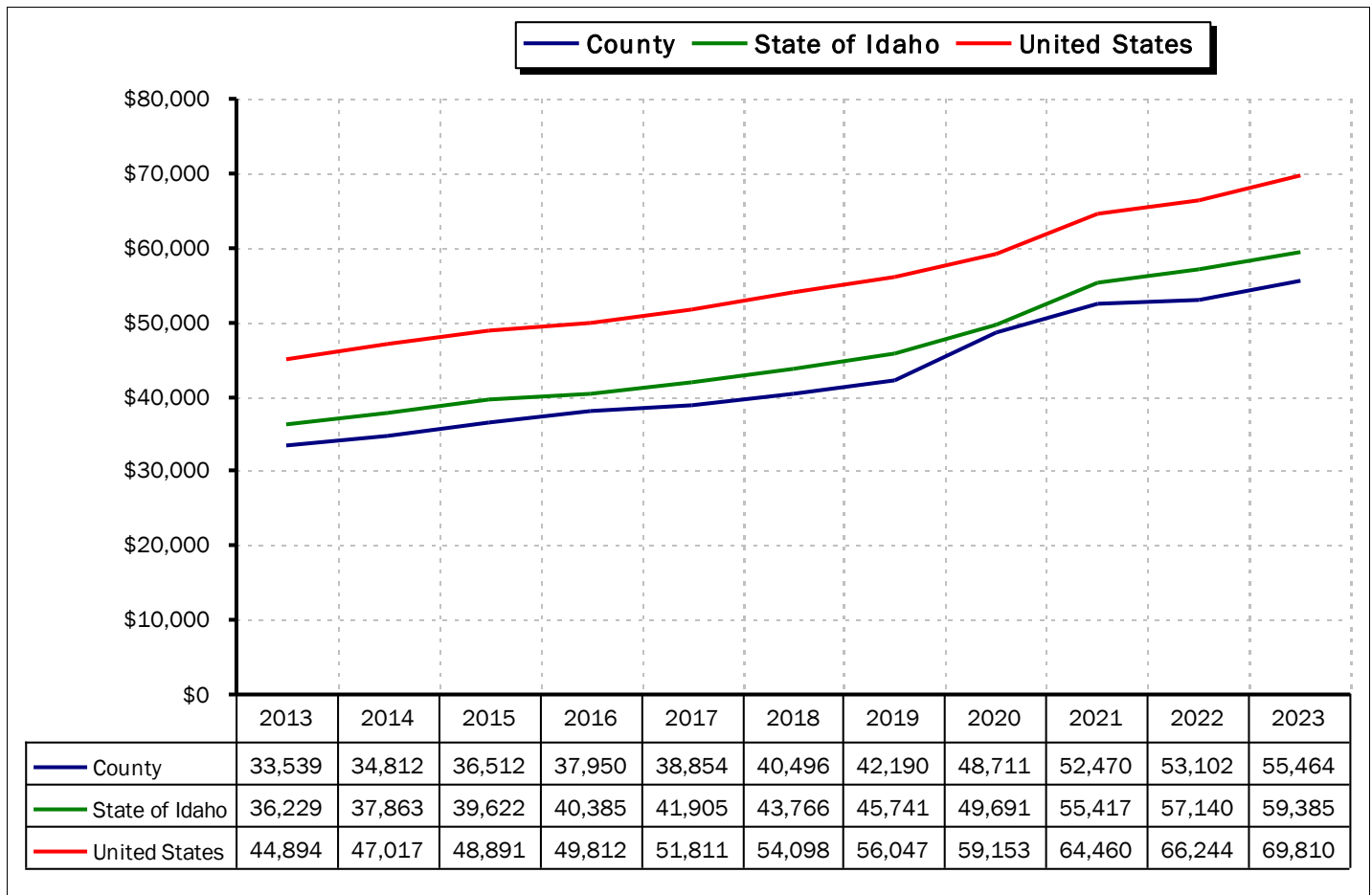

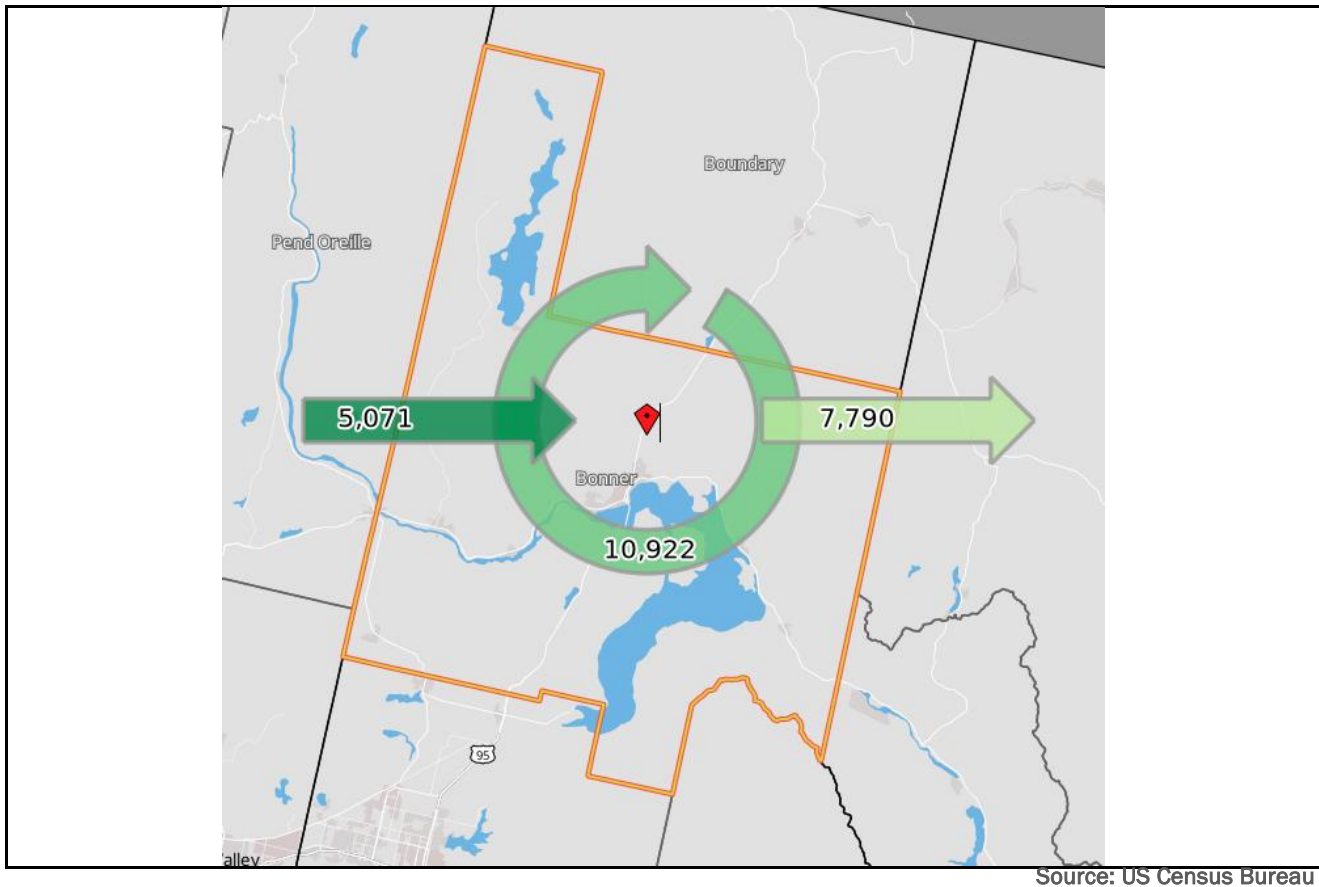
7. Real Per Capita Income, 2013 to 2023

It is estimated that 10,922 workers lived and worked in Bonner County in 2022. Another 5,071 workers were employed in Bonner County but lived outside, while 7,790 workers commuted to other counties for work.
